NOTIFICATION

In continuation of Notification No. 3985/Acd-I dated 08.05.2017 and in pursuance of Syndicate Resolution No. 297 dated 22.6.2017, the following modalities be observed for issue of certificate with regard to fulfilling the five conditions as notified by the UGC in the Gazette of India (Extraordinary) vide UGC Notification No. F.1-2/2016 (PS/Amendment) on 11th July 2016 in favour of the candidates registered for Ph.D. programme prior to 11 July 2009:

- (i) The candidate has to submit an Affidavit to the effect that he/she satisfies all the following five conditions laid down in the UGC Regulations (4th Amendment), 2016 for award of Ph.D. Degree:
- Ph.D. Degree of the candidate awarded in regular mode only.
 - Evaluation of the Ph.D. thesis by at least two external examiners.
 - Open Ph.D. Viva Voce of the candidate had been conducted.
 - Candidate has published two research papers from his/her Ph.D. work out of which one must be in a refereed journal.
 - Candidate has made at least two presentations in conferences/seminars, based on his/her Ph.D. work.

The affidavit should also contain an undertaking by the candidate to the effect that the information provided by him/her is true and in case the same is found to be false/misleading at any later stage, the certificate issued by the University shall stand cancelled.

- (ii) The particulars furnished by the Scholar (including copies of the publications and certificates in support of participation in Seminars/Conferences) are to be duly endorsed by the Guide and/or Head of the concerned Department, and forwarded to the Dean of the respective Faculty for issue of the Certificate in favour of the eligible candidates.

The Certificate shall be issued to the intending candidates by the Dean of the concerned Faculty countersigned by the Guide and the HOD in the prescribed format appended herewith.
